Relationship Summary

We are Opal Capital LLC, an investment adviser registered with the Securities and Exchange Commission. Investment advisory and brokerage services and fees differ, and it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at Investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing. Our firm and financial professionals' registration information are also publicly available on the Investor.gov website.

What investment services and advice can you provide me?

We offer customized investment advisory services to retail investors. We offer our Dividend Growth and Dividend Income Strategies as well as advice on equity securities, exchange-traded funds, and fixed income securities. Our services are generally provided on a discretionary basis, which means that we have the power to buy and sell securities for your account without your prior consent. This authority is usually unlimited and remains in effect until you revoke it. We may provide non-discretionary investment advice, where we make investment recommendations to you and you decide whether to implement the recommendation. We may recommend securities in which we have some proprietary, economic, or ownership interest.

We also offer asset management services as a sub-adviser to third-party investment advisers, who then offer such model portfolios to registered investment adviser firms subscribing to the third-party investment adviser's investment platform. In addition, we will enter into model provider agreements with registered investment advisers and broker-dealers in which we will provide our model portfolios and updates to those who engage the firm for such services. Our portfolio management services are generally offered through third-party investment advisers on either a sub-advised basis or a consulting arrangement as a model provider.

We also subadvise on an exchange-traded fund (DIVZ) and use it in our managed model portfolios.

We review portfolios at least annually as part of our standard service to you. However, we do monitor accounts on a continuous basis and conduct ad hoc reviews if you change your objectives or risk tolerance, upon significant market and economic events, or if we change our investment strategy.

We require a minimum account size of \$100,000 which can be waived at our discretion.

What fees will I pay?

Our asset-based fees are calculated as a percentage of the assets under our management, so our fees will rise and fall with the value of the assets we manage for clients. As a result, we are economically incented to recommend that you place more assets in your account in order to increase the value of your portfolio, because as the value increases, so do our fees.

In addition to our fees, you may be charged transaction or asset-based fees by your custodian for its services. These fees vary depending on the custodian. Under a transaction fee arrangement, the more transactions effected in your account, the more fees you will pay, and high activity in your account does not assure positive portfolio performance. For custodians that charge their fees based upon a percentage of your assets, such fees may be more than would be the case if you are charged a transaction-based fee. Please be mindful of the effect of your portfolio size, the level of activity, and the rate of custodian asset-based pricing. Generally, large portfolios would be disadvantaged by paying an asset-based custodian fee versus a transaction-based fee. Some securities, such as ETFs, carry additional costs.

There are additional fees such as internal fees and expenses charged by mutual funds (i.e., 12b-1 distribution fees and management fees that are assessed within the mutual fund) and exchange-traded funds, postage and handling, transfer taxes, SEC fees for sales of securities.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts, because they can affect the investment advice we provide you. Here are some examples to help you understand what this means:

- Opal Capital's Managing Member serves as Chief Investment Officer for Titleist Asset Management, LLC, and Shorebird Capital, LP, both of which are SEC-registered investment advisers and affiliates of Opal Capital. He also serves as an outsourced Chief Investment Officer for compensation to unaffiliated third-party investment advisers. His services as an outsourced CIO include providing strategic and operational support. As a result of such CIO services, he does not devote his full time and attention to Opal Capital's business.
- We have an incentive to advise you to invest in certain investments, such as the ETF (DIVZ) we subadvise, because
 we earn additional fee revenue when utilizing DIVZ. We manage this conflict by only using this ETF when it is
 appropriate given the size, structure, and diversification of the model portfolio we're managing on your behalf.

Our financial advisors are paid a salary and bonus. These amounts are determined by the overall profitability of the firm, which is dependent upon many factors, including assets under the firm's management. As a result, we might be incentivized to recommend that you add additional assets to your account. We do not receive non-cash compensation.
